So far it looks like we'll have some vintage gear, a magnetic loop antenna, and a baby photo of Phil with his first radio.




May Announcements

First off I am working with seven led signs, 2-3 cameras, some of my computing power and Wayne Hoskins Cell network Internet access thing.



Provide Part 15 802.11b/g access

to the Internet via AD5ST's cellular connection.

Provide "# of stations" worked on LED signs located at each station.

Provide door camera.

What I would need:

People with laptops willing to share a folder over the network to access the Field Day station logs (normally people are willing to do that on the day of the event).

I might need a projector to show the door cam.

What might be possible:

Provide an overall stations worked count via LED sign.

Expand camera network to an outside view, door cam and radio room view.

Have a picture updated about once per minute to k5sld.com or kd5lct.us of the activity going on in the radio room and outside.

Mini status web page that displays the last 5 stations worked by each station updated every minute.

April 2012 Executive Board Meeting Minutes

The regular meeting of the Executive Board of the AARC was held on April 20th, 2012 at 6:38pm. Present were Vice President, Virginia NV5F; Secretary, Andy KB2VQA; Treasurer, Chris K5LTX; Emergency Coordinator, Bill AE5BT; Editor, Rob NV5E; and Training Coordinator and Agent of Record, Phil N5PWW. Absent were the President, Dennis N5ACK; and Trustee, Maurice KM5RF.

Chris K5LTX reported that he was successful in transferring the funds of the AARC to a bank that does not charge a monthly fee. He noted an error in the financial report regarding the interest payed on the Certificate of Deposit. The value should have read 31 cents. He verified that SafeHaven received the donation from the Club.

A motion was made to withdraw the Chase CD upon maturity in June and deposit it in the new bank. The motion carried by a unanimous vote of the Board members present.

Rob NV5E will start a Yahoo Group for the membership of the AARC.

Phil N5PWW will hold a testing session tomorrow.

The meeting adjourned at 7:14pm.

The regular meeting of the Membership of the AARC was called to order at 7:33pm April 20th, 2012 by the Vice President, Virginia NV5F. Other Board members present included Secretary, Andy KB2VQA; Treasurer, Chris K5LTX; Emergency Coordinator, Bill AE5BT; Editor, Rob NV5E; Training Coordinator and Agent of Record, Phil N5PWW. Absent were the President, Dennis N5ACK, and the Trustee, Maurice KM5RF.

Virginia NV5F asked that the meeting attendees introduce themselves by name and call sign.

Rob NV5E printed and distributed the newsletter. He will be starting a Yahoo Group for the AARC.

Phil N5PWW continues to hold test sessions on the first and third Saturdays of the month. He is not currently conducting a training session.

Chris K5LTX reviewed the financial report. He noted that the interest paid on the CD should have read 31 cents. A motion was made and carried to accept for audit the financial report as amended. He successfully transferred the AARC funds from Chase to a bank which will not charge a monthly fee. In June, the CD will mature, and at that time Chris will move those funds as well from Chase. Chris mentioned that SafeHaven acknowledged the donation from the Club.

The minutes for the March meetings were submitted for publication in the April 2012 newsletter. A motion was made and carried to accept the minutes as published.

Bill AE5BT described the plans for Field Day which will be held on June 23 and 24.

A break was taken at 8:15pm. At 8:30pm the meeting resumed, and Virginia gave a presentation on the questions found in the exam pool.

The meeting adjourned at approximately 9:00pm.

Volunteers Needed to Help Test Warning Sirens

If you live or work in Arlington, chances are you have heard the wail of one of our warning sirens. In the event of severe weather, these sirens going off might save your life. But, what if they did not go off? Where would we be then?

Volunteer observers, working in conjunction with the Arlington Fire Department, Office of Emergency Management, assist in the testing of the city's sirens on the first Wednesday of each month, weather permitting. Observers monitor and report on the RC repeater, K5SLD, 147.140 MHz, pl 110.9. There are provisions for call-in reports from non-ham observers as well.

If you have the time available, we would love to enlist your cooperation and radio expertise in this most necessary and rewarding effort. Your report of a malfunctioning siren just might mean the saving of a life or avoidance of bodily injury.

Siren observer lists are emailed to known participants 1 to 2 days in advance. Please monitor our 147.140 repeater starting about 11:45am. on the day of the test. Announcements begin at 12:15pm pm., and the formal net opens about 12:45pm on test day. All observers should be on location and checked in by that time. Testing begins at 1:00pm and is usually concluded by 1:20pm. You may join us at any time that you are able. Detailed maps in PDF and printed formats will be available upon request to assist you in locating the sirens. We particularly need observers in the western and southern parts Arlington.
